VIII. Operations Report

- -Total Customers Report as included in packet. Total Customers were up 105% over last year.
- -Tonnage Report as included in packet.
- -Commercial Program Have been canceling commercial customers. It is an incredibly expensive and labor-intensive program and puts a lot of wear and tear on the vehicles. We have an aging workforce and have people out on medical and sick leave frequently. Processing needs two guys working in processing along with two forklift drivers at all times and it is hard to fulfill that. Trying to focus on the 16 residential trailers. Dearborn County is one of the few programs in the State of Indiana that offers commercial pickups. We still intend to pick up the schools and government offices.
- -St Leon Trailers Rumpke bill for 6 months for the St. Leon Trailers was \$11,000.00. There seemed to be a lot of out of county residents using it and there was a lot of trash in the open dumpsters. Dave was told that if the Rumpke trailers were more than 30% full of garbage, it did not go to Recycling, but went to the landfill. We now have our trailers there and are not seeing as much garbage in the slotted trailers. Dave would be glad to talk to anyone that has questions regarding the trailers.

IX. Director's Report

- -Mileage Rates Resolution The standard rate for 2025 set by the Indiana Department of Administration is 49 cents per mile. Duane Bischoff made a motion to pass Resolution 2025-02, Resolution of Mileage Rates. Kevin Turner seconded the motion. Motion carried.
- -CAC Scholarship There is a \$500 scholarship available at all three Dearborn County High Schools. As of this date, no applications have been received. The deadline is March 1, 2025.
- -Some of the gutters on the Office Building were damaged by the ice during the cold weather in January and will need replaced.
- -Trailer Maintenance box trailer repair and preventive maintenance on all trailers will be done next month.
- -Lawn Mower two bids were included in the packet. After discussion was held, Kevin Turner made a motion to accept the bid of \$4,899.00 from Batesville Farm and Tractor Supply, Inc. Vince Karsteter seconded the motion. Motion carried.
- -Snowblade The snowblade we had broke and we are looking for a new one. It was suggested to wait until winter is over to purchase one and to check with Donny Thompson in Milan.
- -Election of Officers will be held next month. Doug Garner clarified that the Dearborn County Solid Waste Management Board is to have the Lawrenceburg Mayor and a Lawrenceburg City Council member as members and can designate members in their place. Bryan Messmore is the City Council designee from Lawrenceburg and he is able to hold office on the Board.
